## **CFR Breaks Ground on New Central Campus in Fort Dodge**

On Friday, October 20, Community and Family Resources (CFR) hosted a ceremonial groundbreaking to celebrate the beginning of construction for their new treatment facility in Fort Dodge. The new central campus, which will be located at 211 Ave M West, will consolidate all three of CFR's Fort Dodge locations under one roof.

CFR arrived at this exciting moment after assessing the agency's facilities and planning for their future over the past several years. The agency engaged architectural firm, ASK Studio, out of Des Moines and Woodruff Construction of Fort Dodge to design a building to meet the needs of the organization and its clients.

Reflecting on CFR's building project, Executive Director, Michelle De La Riva said, "I am excited most about the recovery experience that those we serve will have in our new facility. With an updated facility that provides for increased access, capacity, security and efficiency, we know that we will be able to provide a welcoming refuge of hope and healing."
